3. SERVICE PROGRAM. Customer has entered into the following service contract TRAINING AND BOARD IS DUE AND PAYABLE ON OR BEFORE THE FIRST OF EACH MONTH TO HIDDEN OAK STABLE OR LATE FEES WILL APPLY. THE CUSTOMER'S CREDIT CARD WILL AUTOMATICALLY BE CHARGED FOR INVOICES PAST DUE BY 10 DAYS AND A \$100 LATE FEE. FIRST MONTH TRAINING AND BOARD IS TO BE PAID IN ADVANCE.

4. ADDITIONAL FEES. The customer understands that additional fees may include but are not limited to: routine and emergency veterinary care, farrier services, hauling, advertising, rehab care, supplements, special feeds, shavings, show fees, entries, tack, etc. A 10% Agent's commission on the purchase or sale price of horses bought and sold will be paid by Customer on any sales transactions.

5. LIMITATION OF LIABILITY AND INDEMNIFICATION. Marie Wallich and Hidden Oak Stable LLC, and its subsidiaries, affiliates, agents, servants, contract labor, volunteers, and employees shall not be liable for any sickness, disease, stray, theft, death or injury that may be suffered by the horse while in Marie Wallich or Hidden Oak Stable, employees, contract labor, volunteers or agent's custody, nor for any loss, damages, or injuries arising out of, or connected with breeding, conditioning, training, breaking, boarding, transporting, showing or other services pursuant to this contract. Customer fully understands, authorizes and assumes the special risks inherent in breeding, conditioning, training, breaking, boarding, transporting, and showing horses and acknowledges that mortality and other insurance is solely the customer's responsibility. MORTALITY AND MAJOR MEDICAL INSURANCE IS HIGHLY RECOMMENDED. All implied warranties, including fitness, merchantability, worth, or otherwise and all special incidental and consequential damages are hereby excluded. No refunds or credits will be given. Any refunds or credits that are given will be at the discretion of Marie Wallich and Hidden Oak Stable LLC. Marie Wallich and Hidden Oak Stable shall also not be liable for any personal injury or disability which the customer or his agents, representatives, or family may receive to themselves or property while on the premises of, or affiliated with Hidden Oak Stable. Under Michigan State law, an equine professional is not liable for an injury to or a death of a participant in an activity resulting from an inherent risk of the equine activity, as defined in section 691.1666 (1) of the Michigan statutes.

6. RELEASE. Horses will not be released or shown until all bills are paid in full, including outstanding veterinary and farrier bills. Payments past due by 10 days will be charged a \$100 late fee and the customer's credit card will be charged. Horses past due by three months will be sold for money owed. A \$50 NSF fee will be charged on returned checks.

7. MEDICAL TREATMENT Current proof of negative coggins is required and Marie Wallich and Hidden Oak Stable LLC has the authority to make medical decisions and keep all horses up to date on vaccinations, shoeing, coggins, and worming and Customer shall be billed for services. Customer is responsible for scheduling their preferred blacksmith for normal 6 to 8 week intervals for trimming and shoeing if not using our house blacksmith. Customer is also responsible for scheduling their preferred veterinarian if not using our house vet. Any and all appointments must be made know to Marie Wallich with at least 48-hour notice.

8. LAW

The terms of this Agreement shall be governed by the laws of the State of Michigan, USA.
